## **UNITED WAY OF THE FLORIDA KEYS OFFERS FREE TAX PREPARATION**

**Florida Keys** – United Way of the Florida Keys is offering 2 FREE tax preparation options for families with limited incomes who live in Monroe County. The VITA (Volunteer Income Tax Assistance) program is designed to assist qualified taxpayers with completion of their annual tax returns and to ensure that limited income families receive every available benefit. Qualification is based on a household income of less than \$54,000 in 2017. UWFK is pleased to offer the VITA program through a grant from Volunteer Florida.

The volunteer tax preparers are IRS-certified and prepared to complete simple tax returns, including identifying available credits. There is absolutely *no charge* to the taxpayer for this service.

Bring Photo ID, Social Security cards, ITINs for all members of your household (no copies), along with all W2s, 1099s, Social Security income, interest statements, unemployment benefit statements, healthcare documentation, your previous year's return if you have it, and any other tax documentation.
